Terms and Conditions

Application Fee: Each new student must pay a one-time administrative fee (non-refundable) of \$500.00. This fee does not guarantee enrolment or placement on a waitlist, and is not part of tuition fees.

Registration Fee: All students must pay the \$3,000.00 Registration Fee (any subsequent siblings enrolled at the same time are offered a Registration Fee of \$2,000.00) upon enrolment and re-enrolment to hold a space for the year in which the application is being submitted. The Registration Fee is due once placement has been offered by the school, and prior to our re-registration deadline each year. This fee is a portion of your child's overall fees and is irrevocably non-refundable.

Responsibility for Payment of Fees: All parents/guardians are responsible to pay The Clover School, a division of Forest Hill Montessori School Inc. ("The Clover School") the charges for the full academic year. In the event of default in the payment of any instalment provided for in this contract, a student may not be allowed to continue classes and parents/guardians will be responsible for all legal fees and reasonable costs of collection for any outstanding amounts due under this contract.

There is no transfer of fees from one student to another, nor from one academic year to another. Classroom placement for students is at the discretion of the Administration.

Any student whose account has not been paid promptly or is in arrears may not be permitted to attend school; may not be permitted to receive records/transcripts; and/or may not be provided with tax receipts.

Records will only be released to other schools or agencies upon signed request from a parent/guardian and only after all accounts due are paid in full.

Withdrawal: Any notice of withdrawal must be made in writing. The Application Fee and Registration Fee are non-refundable, with no exceptions. If a parent/guardian wishes to withdraw a student after enrolling, the following conditions apply, regardless of payment option chosen:

- Withdrawal on or prior to February 28, 2026:** 100% of fees will be canceled and/or returned (excluding Application and Registration fees).
- Withdrawal on or prior to April 30, 2026:** 75% of fees will be canceled and/or returned (excluding Application and Registration fees).
- Withdrawal on or prior to May 31, 2026:** 50% of fees will be canceled and/or returned (excluding Application and Registration fees).
- Withdrawal on or after June 1, 2026:** 0% of fees will be canceled and/or returned.

Late Payments, NSF Fees, Payment Option Changes: All late payments are subject to 1% interest per month (12% per annum). There is a \$100.00 fee applied to any NSF PAD payments or delinquent/declined credit card payments. Any changes to payment options after enrolment has been finalised will incur a \$100 administrative fee.

Tax Receipts: Tax receipts are provided annually via e-mail each February.

Sibling Discounts*: Second, and subsequent siblings, who are in attendance during the same academic year, for a full 10 month period, will receive 10% off their tuition. Please note the sibling discount does not apply to lunch, extended care, activity fees, camp fees or pro-rated tuition due to mid-year starts.
